California DE9C Report

Provides required unemployment reporting, including an XML file that is compatible with the DE9C form. Data is compiled from the employee master and accumulators.

California New Hire Report

Produces an electronic file of all employees in a defined range of dates, locations, and organizations. Send the electronic file to the designated state agency.

California Public Employees Retirement System (CalPERS) Report

Produces period wage and contribution records to submit to CalPERS. Submit the retirement enrollment file to report new hires, appointment changes, leaves, and terminations.

California State Teachers Retirement System Report

Creates an electronic file to send to the California State Teachers Retirement System (CalSTRS).
