Tyler Notify seamlessly integrates with Tyler's Incode utility billing and municipal court solutions, allowing for the creation of customized phone or text campaigns from processes available within your existing solution. Once a message is sent, Tyler Notify posts back to the host server to confirm delivery. For example, in a call campaign, Tyler Notify will report whether a recipient answered the call, if the line was busy, or if the message was delivered to an answering machine or voicemail. This helps to ensure citizens are notified appropriately and enables you to easily schedule follow-up campaigns as needed.
